The Philippines and Thailand clearly had ties and constant interactions even before the two countries officially established diplomatic relations in 1949. The Luzon-made cotton clothes worn by the Thai populace centuries ago, the ceramic wares from Sukhothai and Sawankhalok found in the Visayas and Luzon regions, and the Thai emissary's visits to Rajah Humabon of Cebu even before the arrival of Ferdinand Magellan, all unalterably point to early interaction between the Thais and Filipinos. As a neighboring country, Thailand has indeed been a friendly state to the Philippines – and this relationship must be nurtured and preserved.

His Excellency Mr. Tull Traisorat

H.E. Mr. Tull Traisorat, Ambassador Extraordinary and Plenipotentiary of the Kingdom of Thailand to the Republic of the Philippines, has assumed his post at the Royal Thai Embassy in Manila in June 2022, after completing his tour of duty at the Royal Thai Consulate-General in Hong Kong as Consul-General.

Mr. Traisorat joined the Ministry of Foreign Affairs of Thailand in 1999. Following his post at the Permanent Mission of Thailand to the United Nations in New York during 2001-2005, where he was responsible for matters relating to the Sixth Committee (Legal) of the United Nations' General Assembly, he also took up duties at the Office of the Minister of Foreign Affairs in 2006, and was seconded to the Office of Thailand Trade Representative under the Office of the Prime Minister between 2009-2011. During 2007-2008, he was with the Department of International Economic Affairs in charge of Mekong subregional cooperation frameworks such as ACMECS, GMS, Mekong-US Partnership, etc. During 2013-2017, Mr. Traisorat served under the Department of Treaties and Legal Affairs as Director of Treaty Division and Director of International Law Development Division, with responsibilities ranging from international legal cooperation and treaty interpretation to international trade and investment negotiations. Mr. Traisorat previously held the diplomatic rank of Minister at the Royal Thai Embassy in London from 2017, and was the Consul-General of the Kingdom of Thailand to the Hong Kong and Macao Special Administrative Regions from November 2019 to June 2022.

Mr. Traisorat obtained his Bachelor of Laws (Hons) from Thammasat University and is a Thai Barrister-at-Law. He holds a Master of Laws degree from University of Cambridge and a Doctor of Philosophy in Laws degree from University of London.
